Privacy Statement

Sparta R-III School District Statement of Privacy.

Sparta R-III School District is committed to protecting your privacy. This Statement of Privacy applies to Sparta R-III School District web site and governs data collection and usage at all Sparta R-III School District sites and services; it does not apply to other online or offline sites, products or services. Personal information of all users is collected, used and disclosed as described in this Statement of Privacy.

Collection of your Personal Information

As an E-commerce Web site, Sparta R-III School District collects personal information, such as your e-mail address, name, home or work address or telephone number. Information collected by Sparta R-III School District is used solely for the purpose of billing and shipping your online purchases. Sparta R-III School District does not collect any information about your computer hardware and software. Sparta R-III School District encourages you to review the privacy statements of Web sites you choose to link to from Sparta R-III School District so that you can understand how those Web sites collect, use and share your information. We are not responsible for the privacy statements or other content on Web sites outside of the Sparta R-III School District Web site.

Use of your Personal Information

Sparta R-III School District and its operational service partners collect and use your personal information to process product orders and deliver the products requested. It is possible that Sparta R-III School District may also use personal information to inform you of other products or services available from Sparta R-III School District and its affiliates. Sparta R-III School District may also contact you via surveys to conduct research about your opinion of current services or of potential new services that may be offered. Sparta R-III School District does not sell, rent or lease its customer lists to third parties. Sparta R-III School District may, from time to time, contact you on behalf of external business partners about a particular offering that may be of interest to you. In those cases, your personal information (e-mail, name, address, telephone number) is not transferred to the third party. We occasionally hire other companies to provide limited services on our behalf, such as handling the processing and delivery of mailings, providing customer support, processing transactions, or performing statistical analysis of our services. We will only provide those companies the personal information they need to deliver the service. They are required to maintain the confidentiality

of your information and are prohibited from using that information for any other purpose. Sparta R-III School District does not use or disclose sensitive personal information, such as race, religion, or political affiliations, without your explicit consent. Sparta R-III School District may access and/or disclose your personal information if required to do so by law or in the good faith belief that such action is necessary to: (a) conform to the edicts of the law or comply with legal process served on Sparta R-III School District or the site; (b) protect and defend the rights or property of Sparta R-III School District, including its Web site; or (c) act under exigent circumstances to protect the personal safety of users of Sparta R-III School District or the public. Personal information collected on this site may be stored and processed in the United States or any other country in which Sparta R-III School District or its affiliates, subsidiaries or agents maintain facilities, and by using this site, you consent to any such transfer of information outside of your country.
